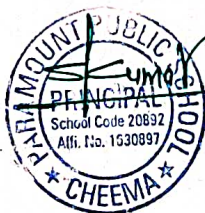
### Building Safety Report


Name of School: Paramount Public School, Cheema, (District Sangrur).

- b) In case any addition, alteration or expansion and modification to this building are done certificate may be obtained after the completion from the undersigned.
- c) In case the building is affected by flood or if there is any settlement of walls/ foundation or sagging of roofs etc. immediate inspection of the undersigned be arranged to check stability and safety of the building.
- d) A separate certificate regarding Fire Fighting should be obtained from the competent Authority.
- e) A separate certificate regarding Electrical works should be obtained from the competent Authority.
- f) The owner of the building / Management is fully responsible regarding safety of the building from all angles in spite of the report.
- g) The covered area of the building is As per Drawings Sft.
- h) The report is not valid for legal purpose.

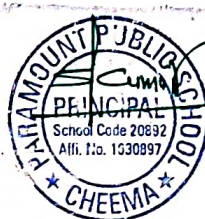
